

TUITION

This is a <u>9-month contract/commitment</u> (with an optional summer lessons contract). A signed tuition contract is required for reduced and/or group lesson pricing (see options below).

Tuition is paid in advance by check or cash on a monthly basis.

This <u>includes</u> all lessons <u>(44+</u>). All lessons must be <u>pre-scheduled</u>. Materials/music are <u>NOT</u> included. THERE ARE NO MAKE-UP LESSONS OR CREDITS.

OPTIONS FOR PAYMENTS*: (*\$10 discount per sibling with signed contract - individual or group)

Individual (Private) Lessons – 30-minute sessions weekly

9 payments. \$120.00 each month

Group Lessons (2-5 students)

2 students in a group - 9 payments. \$100.00 each month per student, **45-minute sessions weekly** 3-5 students in a group - 9 payments. \$90.00 each month per student, **50-55 minute sessions weekly**

Monthly payment with no contract

Paid in advance \$40 per session – approx. \$160/month (private lessons) - 30-minute sessions weekly

SCHOOL YEAR SCHEDULE: September – May weekly *See closure schedule for exceptions.

- 30 minutes private with instructor
- 45-55 minutes in a group with instructor

SUMMER SCHEDULE: June - July - August

- Regular contract rates for students on 9-month contract/pre-scheduled lessons.
- Month-to-month rate applies otherwise

TERMS

If you wish to cancel this contract, you may cancel by mailing a written notice by certified or registered mail to the studio. The notice must say that you do not wish to be bound by this contract and must be delivered or mailed before midnight of the third business day after you sign this contract. The notice must be delivered or mailed to:

You may cancel this contract if you relocate your residence further than 50 miles from Cobalt Music Center, by paying a cancellation fee for an amount equal to 30% of the remaining contract. This contract may also be cancelled in a case of death or if the studio ceases operation.

If you become disabled, you shall have the option of (1) being relieved of liability for payment on that portion of the contract term for which you are disabled by paying a cancellation fee for an amount equal to 30% of the remaining contract, or (2) extending the duration of the original contract at no cost to you for a period equal to the duration of the disability. You must prove such disability by a doctor's certificate, which shall be enclosed with the written notice of disability to the studio. You may cancel this contract for any reason at any time by paying a cancellation fee for an amount equal to 50% of the remaining contract.
